To qualify for reapproval using this form, the expired plat **SHALL NOT BE CHANGED** from the previously approved version, unless otherwise specifically allowed or required by the OMPC. Due to regulatory or other changes that affect the plat after the original approval date, the OMPC may require full submission of a new plat using Form 130.
