Although right-of-way dedication is not required along existing roadways, where a 30-foot half right-of-way does not exist, each tract must contain acreage above 10 acres that would allow for future right-of-way to be dedicated while remaining over 10 acres. <b>Submit original and two (2) copies of the plat</b> to Planning Office at any time.
